A person may be granted a non-practising licence for a total of no more than three consecutive licensing periods (36 months). Non-practising members remain on their same 3-year CCP reporting cycle and must fulfill the CCP requirements. Non-practising members may make application to the Registrar to upgrade to a practising licence within the licensing year and be credited this fee towards a full licence. 	\$330.00

<ul style="list-style-type: none"> • New Graduate Licence: May be granted to an applicant that has not been registered/licensed in any other jurisdiction and is submitting an application in the same calendar year as graduation from a dental hygiene program. 	\$330.00
<ul style="list-style-type: none"> • Temporary Licence: Valid for no more than 2 months and only for the purpose of participating in or conducting a clinical course, study club, or research program. 	\$330.00
